Links to Learning Program provides cash awards to local public school teachers to pay for educational materials and or enrichment activities for the classroom. These awards fund items such as books, technology, field trips, music, art and scientific equipment. This year 187 individual awards were given, impacting thousands of students. Since the program began in 1992 over \$1.3 million has been awarded in special support to help children learn.

4b (Code:) (Expenses \$ 140,787 including grants of \$) (Revenue \$)

Operation School Bell® Provides new school clothing to needy pre-school and elementary public school students. This year 1,604 students from 20 area schools were outfitted with new shirts, slacks, sweaters, winter coats, socks, underwear and hygiene kits. This program strives to increase self esteem and encourage regular school attendance and performance. This activity involved 133 member volunteers and over 3,400 service hours.

4c (Code:) (Expenses \$ 69,132 including grants of \$ 66,000) (Revenue \$)

Assisting Women's Achievement Scholarships: Program provides scholarships to women over age 24 with at least 60 credit hours to be used to complete undergraduate college degrees at Stephens College, Columbia College, or the University of Missouri. Beginning in 2016, scholarships were also provided for certification programs offered through the Columbia Area Career Center. Recipients are selected by the individual schools using specified established criteria. This year, 44 students were selected. Since the program began in 2005, 249 students have received scholarships.

Operation School Bell Program, to families referred by local shelters or agencies, to the Columbia Public Schools, the Boone County Council on Aging, and Welcome Home, a transitional home for veterans. We purchase hygiene items and package them to be distributed as needed. This year we packaged 3,015 kits, at a cost of \$24,684. Over the past 25 years, we have purchased, packed and distributed 33,334 hygiene kits.

Operation Share- Since 2009, the chapter shares our resources with other Mid-Missouri agencies. If an item is donated to us that is not suitable for our needs, we work to find another local agency that can use the resource.
